# ABOUT THE OPPORTUNITY

The Miles Hall Foundation (TMHF) seeks a visionary and strategic Program Director to lead, develop, and expand our mission-driven programs. This contractor role operates at the heart of our work, ensuring that TMHF's advocacy, outreach, and educational initiatives create a real impact on the communities we serve.

The Program Director will report to the Executive Director (*with initial onboarding and coordination from the interim Deputy Director*) and is a key member of the Executive Leadership Team. The Program Director will play a critical role in executing TMHF's three-year strategic plan, expanding our impact, and ensuring the sustainability of our work.

This role offers program creation and management in addition to opportunities to take the organization to the next level. The program director will drive systemic change and make a real difference in the lives of those most affected by mental illness, racial injustice, and policing.

We strongly encourage applicants with lived experience related to mental illness, racial inequality, policing, or systemic injustice. Your perspective and leadership are invaluable in guiding our work.

This is a **full-time independent contractor position**, possibly through midyear 2026. Remote-friendly role with flexibility, but some in-person engagement required for program management, participation at selected events, trainings, and meetings.

Work scope, deliverables and deadlines, schedule of availability and weekly benchmarks will be established between contractor and organization. Overall success will be measured by the delivery of agreed-upon deliverables and milestones. Our intention is to evaluate contractor for a possible transition to a W-2 employee based on:

- Mutual Fit
- Performance Evaluation

#### **Program Strategy & Development**

- Provide feedback on our 2-3 year "Program Roadmap" helping to ensure that is is clear and aligned with TMHF's strategic goals, and long-term vision.
- Pilot, and iteratively implement impactful programs/initiatives and associated KPIs that ensure TMHF programs are mission-aligned, financially sustainable, and measurably responsive to community needs.
- Work collaboratively with the cross-functional leadership team and our community partners to deliver on, refine, and perhaps expand new and existing programs and initiatives.
- Collaborate closely with the fundraising leads to ensure that programs are strategically positioned, clearly communicated, and financially structured in ways that attract and retain funder support. This includes contributing to program budgets, articulating program value, and aligning initiatives with funding opportunities.
- As an independent contractor, you retain full discretion over how, when, and where you perform these tasks, provided you meet agreed-upon deliverables, deadlines, and objectives.

- Oversee day-to-day program operations, ensuring quality, efficiency, and alignment with TMHF's goals.
- Lead and support program staff, volunteers, and interns, fostering a strong culture of collaboration and mission-driven work.
- Establish and track key performance metrics to measure program impact and effectiveness.
- Provide regular program updates and reports to leadership, funders, and stakeholders.

- Serve as a representative of TMHF, advocating for programs, policies and initiatives that align with our mission.

- Collaborate with the fundraising team by offering program insights, budget clarity, and impact data to strengthen funding proposals and support long-term stewardship of resources.

- Bachelor's degree required; Master's preferred (in Nonprofit Management, Social Work, Public Administration, or related field).
- 3–5+ years of experience in program management, preferably in a mission-driven early-stage nonprofit.
- Experience in community organizing, advocacy, or public service required, especially if your work has been with impacted families and communities.
- Strong project management, program-specific budget oversight, and evaluation skills.
- Experience in mental health services, racial justice, and disability justice required.

#### **WORKING CONDITIONS**

- This is a full-time independent contractor role.
- Bay Area–based preferred. Flexible scheduling that is remote-friendly, with in-person participation needed for meetings, training, and events.
- As an independent contractor, you are solely responsible for all taxes, insurance, benefits, and business expenses.
- The contractor will be required to regularly invoice TMHF for services rendered; said services will be the agreed upon scope of deliverables and milestones.
